RESOLUTION NO. 2014-05

Approving Projects for Inclusion in the Draft 2040 Long Range Transportation Plan

WHEREAS, the Eastern Shore Metropolitan Planning Organization (MPO) is the organization designated by the Governor of the State of Alabama as being responsible, together with the State of Alabama, for implementing the applicable provisions of 23 USC 134 and 135 (amended by MAP-21 Sections 1201 and 1202, July 2012); 42 USC 2000d-1, 7401; 23 CFR 450 and 500; 40 CFR 51 and 93; and

WHEREAS, 23 CFR 450.322 requires Metropolitan Planning Organizations to develop a long range transportation plan with a minimum twenty-year planning horizon, to be updated a minimum of every four years, be multimodal and function as a single integrated transportation network, and be available to the public and interested parties for review and comment prior to approval by the MPO according to the provisions of 23 CFR 450.316(a); and

WHEREAS, the following projects have been approved for inclusion in the Draft 2040 Long Range Transportation Plan:

City of Spanish Fort

- SR 225, from Blakeley Way to School Rd; Construction of sidewalk

Town of Loxley


- Relham Drive, from CR 49 to Holley Street; Resurfacing
- Holley Street, from SR 59 to Relham Drive; Widening and resurfacing
- CR 49, from Fackler Road to US 90; Widening, resurfacing and drainage improvements
- SR 59/Flowerwood Nursery Rd; Intersection Improvements
- US 90/SR 59/CR 68; Realignment and Construction of 4-way intersection
- Fackler Road, from CR 49 to CR 55; Widening and resurfacing
- CR 62, from SR 59 to Loxley Town Limits; Widening and resurfacing
- CR 64, from SR 59 to Loxley Town Limits; Widening and resurfacing

Baldwin County

- CR 64, from US 98 to SR 181; Resurfacing
- CR 68, from Loxley Town Limits to Baldwin Beach Express; Widening and resurfacing
- CR 64, from Loxley Town Limits to Baldwin Beach Express; Widening and resurfacing
- Scenic Hwy 98 at Point Clear Creek; Construction of Pedestrian Bridge
- Brats Central Hub; Construction of Boarding/De-boarding Canopy Shelter

THEREFORE, BE IT RESOLVED that the Eastern Shore Metropolitan Planning Organization, having reviewed and approved the foregoing, does hereby adopt the listed projects for inclusion in the Eastern Shore MPO Draft 2040 Long Range Transportation Plan Visionary/Needs Project List.
