RESOLUTION NO. 2018-18

Supporting State Transit Performance Management Targets

WHEREAS, the Eastern Shore Metropolitan Planning Organization (MPO) is the organization designated by the Governor of the State of Alabama as being responsible, together with the State of Alabama, for implementing the applicable provisions of 23 USC 134 and 135 (amended by the FAST Act, Sections 1201 and 1202, December 2015); 42 USC 2000d-1, 7401; 23 CFR 450 and 500; 40 CFR 51 and 93; and

WHEREAS, federal regulations require that the Metropolitan Transportation Plans and Transportation Improvement Programs include Transit Performance Management Targets for urbanized areas and;

WHEREAS, the ESMPO staff in coordination with the Federal Highway Administration, Federal Transit Administration, and the Alabama Department of Transportation has reviewed the requirement to adopt Transit Asset Management(TAM) Targets for use in the transportation process;

ALDOT Transit Asset Performance Measures—Tier II (5307/5311 agencies that are ALDOT's subrecipient of FTA funds)

- Asset Category: Rolling Stock (All revenue vehicles)
 - o Performance Measures
 - Age % of revenue vehicles within a particular asset class that have met or exceed their Useful Life Benchmark
 - o Performance Targets
 - Vans -- replace 10% of current active inventory
 - Cutaway Buses ---replace 10% of current active inventory
 - Body-in-Chassis-- replace 10% of current active inventory
 - Full size buses-- replace 10% of current active inventory
 - Statewide Goals will be to replace at least
 - o 26 vans
 - o 3 small buses (16-21 Passengers)
 - o 4 small buses (24-27 Passengers)
- Asset Category: Equipment (Non-revenue vehicles)
 - o Performance Measures
 - Age % of revenue vehicles within a particular asset class that have met or exceed their Useful Life Benchmark
 - o Performance Targets
 - Overall replacement of the current inventory by 10%
 - Equipment is defined as nonexpendable, tangible property, having a useful life of at least one year. (ALDOT will inventory only FTA purchased equipment over \$50,000)

- Asset Category: Facilities (ALDOT will only rate FTA funded facilities)
 - o Performance Measures
 - Conditions % of facilities with a condition rating below 3.0 on a FTA Transit Economic Requirement Modal (TERM) Scale
 - o Performance Targets
 - No more than 20% of FTA funded Facilities to have a rating of below 3.0 (Good)
 Condition

NOW, THEREFORE, BE IT RESOLVED that the Eastern Shore Metropolitan Planning Organization Policy Board concurs with the recommendation MPO staff and agrees to support the Transit Performance Management Targets as approved by the Alabama Department of Transportation.
