## **RESOLUTION NO.** 2018-22

Adoption of Alabama Statewide Performance Measure Targets System Performance Measures (PM3)

WHEREAS, the Eastern Shore Metropolitan Planning Organization (MPO) is the organization designated by the Governor of the State of Alabama as being responsible, together with the State of Alabama, for implementing the applicable provisions of 23 USC 134 and 135 (amended by the FAST Act, Sections 1201 and 1202, December 2015); 42 USC 2000d-1, 7401; 23 CFR 450 and 500; 40 CFR 51 and 93; and

WHEREAS, federal regulations require that Metropolitan Transportation Plans and Transportation Improvement Programs include System Performance Measure Targets for urbanized areas; and

WHEREAS, MPO staff, in coordination with the Federal Highway Administration, Federal Transit Administration, and the Alabama Department of Transportation has reviewed the requirement to adopt these System Performance Measures and Targets for use in the transportation process; and

WHEREAS, MPO staff recommends the Eastern Shore MPO support and adopt the Statewide System Performance Measures and Targets approved by the Alabama Department of Transportation as follows:

System Performance Measure	Baseline Score (2017)	2-Year Performance Target (2019)	4-Year Performance Target (2021)	Interpretation for Baseline Scores (2017)
% of Person- Miles traveled on Interstate System that is Reliable	96.4%	96.4%	96.4%	96.4% of all Alabama interstate travel is reliable (where reliable if defined as 80% of travel times being less than 150% of the average travel time
% of Person- Miles traveled on Non- Interstate System that is Reliable	93.8%	93.7% *Not required to be reported to FHWA	93.6%	93.8% of all Alabama non-interstate NHS travel is reliable (where reliable is defined as 80% of travel times being less than 150% of the average travel time)
Truck Travel Time Reliability Index	1.19	1.20	1.21	Across Alabama, the 95th percentile Interstate truck travel times are on average 19% greater than the 50th percentile (average) travel time.

**THEREFORE, BE IT RESOLVED** that the Eastern Shore Metropolitan Planning Organization Policy Board concurs with the recommendation of MPO staff and agrees to support the Statewide System Performance Measure Targets as approved by the Alabama Department of Transportation.
